Verbal Updates:

VI. PSP Report

Meyers: PSP is holding a toy and game book sale for families. Proceeds will be used for the school-wide technology goal to support the purchase of new laptops. Multi Cultural Night is May 13th.

Turnstone: The PSP sponsored Adult Social will be held on April 9th. Turnstone PSP is still looking for officers to serve in the positions of Treasurer, Secretary and Fundraising.

Western Sierra: Family Night at Chevy's was successful with 25% being donated to the Western Sierra PSP. These Family Nights are held the first Thursday of every month. The PSP is sponsoring a book fair to be held the week before Spring Break and their Silent Auction Fundraiser will be held April 17th. All details are in their newsletter.

VII. Information/Action

(a) Employee Handbook

Joanne Moody gave a quick overview to the board of the changes that will be coming to the board for approval on April 19th.

(b) Budget Update

Executive Director Patterson distributed the Legislative Analysis Office report on the proposed Governor's Budget. A budget workshop is scheduled for March 16 at the Western Sierra Atrium for parent stakeholders to be informed of the current budget situation.

(c) Second Interim Budget Ratification

(d) Auditor Selection

(e) Governance Committee: Decision Matrix – Sean Jones

Sean Jones, Chair of the Governance Committee provided an update of the committee's work and reviewed the Vroom-Yetton Flow chart and matrix with the Board. The Board will now review the matrix and set the next steps for the implementation of the decision matrix.

(f) Staffing Discussion (2010-2011)

The board was updated regarding the faculty hiring being considered for the 2010-11 school year. Due to the growth at Western Sierra, and the 30-2 class sizes being changed, additions and reductions in staff are being considered on a case-by-case basis.

(g) Annual Review of Educational Program/Update on School Wide Goals

Mary Decker, Diana Wilson, Megan Curtis and Laura Reagan gave a presentation reviewing the overall educational program, progress on the school wide SMART goals for Rocklin Academy elementary program and reviewed the implementation of the new initiatives for the 2009-2010 school year. Areas covered were the new Scott Foresman Envision Math curriculum, K-12

Online Math, the Rosetta Stone Language Program, and the school's participation as part of the National Learning School Alliance. The review of the educational program at Western Sierra will occur in April.

(h) Parent Survey Draft

Samples of the Parent, Staff and Student Surveys were distributed to the board. The surveys have been modified only slightly to make comparisons from year to year consistent. The survey results will be brought back to the Board in May or June.

(i) Membership in El Dorado Charter SELPA for Turnstone and Meyers Schools

Rocklin Academy Turnstone and Meyers are currently schools of the district for the purpose of special education to LEA's. It is being considered that these schools follow Western Sierra and enroll as LEA's in the El Dorado Charter SELPA. RUSD has been notified that this option is being considered. The board approved Executive Director Patterson to go forward with becoming a member of the Charter SELPA after meeting with RUSD, or if input from RUSD warrants further discussion, to bring the item back to the Board.
